Park improved thanks to Eagle Scout project

ALACHUA - The wooden bleachers at the Skinner Park baseball field look as good as new thanks to Andrew S. Jenkins' Eagle Scout project.

Jenkins, along with fellow Troop 88 Boy Scouts, spent the better part of Saturday refurbishing the bleachers from which numerous ballgames are watched every year. Jenkins also constructed two additional smaller benches near the field.

"I think it turned out pretty well. I like the finished project and I think it will benefit my community for years to come," he said.

While the crew put in dozens of manhours collectively on Saturday, Jenkins, just 16 years old, says he spent about 56 hours in pre-planning for the project. The project is just one requirement that Jenkins must meet to earn the rank of Eagle, Boy Scouting's highest honor.

"There is a lot more paper work yet to go and additional presentations to make to the Eagle Review Board," said Jenkins.

The 11th grade Santa Fe High School student is well on his way to reaching the Eagle Rank with 31 merit badges already completed, 12 of which are required. Additional merit badges earned beyond his Eagle rank will be credited toward Eagle Palms, an award distinguishing Eagle Scouts for their ongoing commitment and involvement

Jenkins is also a member of the Order of the Arrow, an auxiliary scouting organi-

zation that focuses on service to scouting, including maintaining area camps.

Negro baseball league players help teach diversity

color of their skin.

These men were part of the Negro Baseball League. They played on all-black teams against other allblack teams. They played in the pre-civil rights era of segregation.

They stopped for lunch in Alachua that afternoon on their way from the Babe Ruth World Series down to Ocala for their next appearance as part of a two-day series of events for the 2010 Negro Baseball League Project.

According to an August press release, Cox Communications launched the project in Gainesville in 2008, with the intent of promoting diversity within its own company as well as the surrounding community.

Now in the program's third year, Cox, with the support of ESPN, put on an invitation-only community luncheon, a public autograph signing at the Paddock Mall and an appearance and autograph signing at the Cal Ripkin 10-year-old World Series, in Ocala.

But in between their schedule of events, the players came to Alachua to check out the Babe Ruth World Series, and they stayed to eat before heading back to Ocala for the night.

Mike Giampietro, vice president of public and government affairs for Cox Communications Florida, explained that these men are "a piece of living history," and by sharing their experiences they can help to

to tell could indeed write the pages of history books. For instance, Harold "Buster" O. Hair remembers when he met Tony Stone in 1953. She was a black woman who played for the otherwise allmale Indianapolis Clowns. He said she could hold her own on the baseball field, but "she was still feminine," he added, chuckling. She was a huge draw, he said. People would come just to see her play.

Billy Reed, who was never officially a member of the Negro league but coached a team in Tampa, told the story of how baseball kept him from having to go to war.

He was going to play for a team in North Dakota, he said, when he got a phone call from his "mamma," and she told him he got a letter in the mail from the federal government.

started laughing He was drafted, but after someone watched him play in a casual game on base, he was reassigned to go play for an official military team instead of being shipped overseas to fight, and eventually he was let out early to go back to school.

These were just a couple of the many reminisces of history the men shared over their Friday afternoon meal.

Giampietro said they decided to eat at Conestogas because they wanted to go to a place that was as local as it could get. Its menu had food they would like, he said, and the guys really like being in places that represent the community; places where they will be able to interact with local people.
